

COUNTY BOARD OF SUPERVISORS PROCEEDINGS

Courthouse, Clay Center, Nebraska, July 26, 2011 at 9:00 A.M.

The Clay County Board of Supervisors met July 26, 2011 as per public notice given in the Clay County News on July 20, 2011 a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agenda was communicated in the advance notice of the meeting and on the county website. Chairman Fintel presided with roll call showing the following present: Nuss, Samuelson, Anderson, Schmidt, Johnson, Shaw and Fintel. Minutes of the meeting held July 19, 2011 were sent to the board members. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Fintel stated that the open meeting law poster is posted on the west wall in the back of the room.

Motion by Shaw and seconded by Schmidt to approve the minutes of the meeting held July 19, 2011 as mailed. On roll call, yea: Samuelson, Anderson, Schmidt, Johnson, Shaw, Nuss and Fintel. Motion carried.

During Public Comment, Brenda Hansen expressed a concern that the weather warnings are not being sent since the county switched from Code Red to Delta Alert. The board said they would talk to Loren when he met with them later and get an answer.

Thomas Roemmich II, Highway Superintendent reported that the first ½ mile of the Edgar Road would be done today. The agreement with NRCS was discussed; the type of culverts and building up of the road. The purpose of this project is to equalize water on each side of the road. The work report and an easement were presented. Maintenance of a road in the NAD was discussed. It does not seem to be clear whether the road is a county road or not. This will be discussed with the County Attorney. PTO and comp. time were also discussed with Tom as well as working 10 hour days. The department does not want to work 10 hour days; the possibility of paying out any unused comp. time at the end of the year (or another designated time) was discussed. The board discussed resurfacing 20 miles of roads north of Highway 6. Tom will look into bonding this project and report back at the next meeting.

Motion by Nuss and seconded by Shaw to approve the easement requested by Jason Friesen for an electric and water line across Road 316 from the SW ¼ Sec. 16-T7N-R5W to NW ¼ Sec. 21-T7N-R5W to supply a building for domestic use. On roll call, yea: Anderson, Schmidt, Johnson, Shaw, Nuss, Samuelson and Fintel. Motion carried.

Motion by Johnson and seconded by Samuelson to approve the Highway Superintendent's road work report for the month of July 2011. On roll call, yea: Schmidt, Johnson, Shaw, Nuss, Samuelson, Anderson and Fintel. Motion carried

Motion by Anderson and seconded by Nuss to authorize the chairman to sign the Memorandum of Understanding for the WRP Wetland Restoration Project in SE ½ 29-7-

6 between Clay County Nebraska and NRCS. On roll call, yea: Johnson, Shaw, Nuss, Samuelson, Anderson, Schmidt and Fintel. Motion carried.

Jeff Franklin, County Sheriff reported that he was helping with the audit with the Fire Departments; the Taurus has been sold and he has received two bids on the Chevy. There have been a lot of accidents with deer and a record # of DWI's. The awning is almost done and then they will begin parking the EM vehicle under it. The board discussed the possiblity of rocking that area once the dirt work is done and also rocking some of the area in the front to reduce maintenance.

Carissa Uhrmacher, Project coordinator presented the budget request for the South Central Partnership Grant. The Juvenile Services County Aid project was discussed and the award papers presented for signatures.

Motion by Nuss and seconded by Shaw to authorize the chairman to sign the Juvenile Services County Aid Grant Award form and the Subgrant Special Conditions form. On roll call, yea: Shaw, Nuss, Samuelson, Anderson, Schmidt, Johnson and Fintel. Motion carried.

Gene Ulmer the county's budget preparer answered questions about the budget preparation. He has the information from the Clerk and Treasurer and will begin the budget preparation. The board will let him know about bonding a road project.

Travis Songster, custodian reported that he was removing the old caulking and recaulking at the Service Building. He will work on the doors to prevent future leaking. Capping the sprinklers in preparation for the new maintenance building was discussed. It was decided to advertise to sell the existing storage building.

Loren Uden, Emergency Management Consultant did not meet with the board but the chairman called to ask about the Delta Alert system. There was a problem with the transfer of information from Code Red but that has been taken care of.

Ted Griess, County Attorney discussed the maintenance of the NAD road with the board and the Highway Supt. Ted will look into this further to try to determine if this is a county road or not.

Motion by Johnson and seconded by Samuelson to approve the claims plus the tabled Road Fund claim #3200 and authorize the County Clerk to issue warrants on the respective funds. On roll call, yea: Nuss, Samuelson, Anderson, Schmidt, Johnson, Shaw and Fintel. Motion carried.
