



COUNTY BOARD OF SUPERVISORS

Courthouse, Clay Center, Nebraska, October 22, 2013 at 8:00 A.M.

The Clay County Board of Supervisors met October 22, 2013 as per public notice given in the Clay County News on October 16, 2013 a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agenda was communicated in the advance notice of the meeting. Chairman Fintel presided with roll call showing the following present: Anderson, Schmidt, Johnson, Shaw and Fintel; absent: Nuss and Samuelson. Minutes of the meeting held October 15, 2013 were mailed to the board members. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, Ivan Fintel stated that the open meeting law poster is posted on the west wall in the back of the room.

Nuss and Samuelson entered the meeting at 8:04 A.M.

Motion by Schmidt and seconded by Johnson to approve the minutes of the meeting held October 15, 2013 as mailed. On roll call, yea: Samuelson, Anderson, Schmidt, Johnson, Shaw, Nuss and Fintel. Motion carried.

There was no Public Input.

Thomas Roemmich II, Highway Superintendent reported on culvert work and the progress of the asphalt project. There have been some change orders associated with the asphalt project in order to deal with situations that have come up. At this point the project should still come in under budget. The board discussed hiring another motor grader operator. Motor patrol buildings were also discussed. It was decided to look at putting up buildings in Sutton and Fairfield.

The paperwork that needs to be sent to the state for the road budget was presented. Motion by Anderson and seconded by Nuss to authorize the chairman to sign the Certification to Board of Public Roads Classifications & Standards and the Road & Bridge Contracts Report to Board of Public Roads Classifications & Standards for the Road Department Budget. On roll call, yea: Anderson, Schmidt, Johnson, Shaw, Nuss, Samuelson and Fintel. Motion carried.

The agreement from Glenwood Telephone Membership Corporation who is in the process of constructing a buried fiber optic toll cable was received with the requested information. Motion by Shaw and seconded by Schmidt to sign the Utility Agreement received from Glenwood Telephone Membership Corp. for a fiber optic toll cable in Spring Ranch township. (see document for legal descriptions) On roll call, yea: Schmidt, Johnson, Shaw, Nuss, Samuelson, Anderson and Fintel. Motion carried.

The applications that were received were reviewed.

The Board had openings on the agenda and decided to move up the board of equalization time. The agenda states that the scheduled times are tentative and the

Motion by Shaw and seconded by Samuelson to recess as the Board of Supervisors at 9:48 A.M. On roll call, yea: Johnson, Shaw, Nuss, Samuelson, Anderson, Schmidt and Fintel. Motion carried.

Motion by Samuelson and seconded by Schmidt to resume session as the Board of Supervisors at 9:53 A.M. On roll call, yea: Shaw, Nuss, Samuelson, Anderson, Schmidt, Johnson and Fintel. Motion carried.

Motion by Anderson and seconded by Shaw to approve the claims and authorize the County Clerk to issue warrants on the respective funds. On roll call, yea: Nuss, Samuelson, Anderson, Schmidt, Johnson, Shaw and Fintel. Motion carried.

Ted told the board that he has some samples to give the Highway Superintendent to aid in the completion of Clay County's ADA policy. Ted will also find out why the lease for the Leicester farm has not been returned.

Probationary time and starting wages for the custodial position were discussed. Appointments will be made to interview two of the applicants.
