Courthouse, Clay Center, Nebraska, November 28, 2023 at 9:00 A.M.

The Clay County Board of Supervisors met November 28, 2023 as per public notice given in the Clay County News on November 22, 2023 a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agenda was communicated in the advance notice of the meeting. Chairman L. Wayne Johnson presided with roll call showing the following present: Scott Bitterman, Glen Becker, James Pavelka, Dick Shaw, and L. Wayne Johnson; absent: Eric Samuelson, Ivan Fintel. Minutes of the meeting held November 21, 2023 were mailed to the board members. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman, L. Wayne Johnson stated that the open meeting law poster is posted on the west wall in the back of the room.

All present stood for the Pledge of Allegiance.

Motion by Pavelka and seconded by Bitterman to approve the minutes of the meeting held November 21, 2023 as mailed. On roll call, yea: Bitterman, Becker, Pavelka, Shaw and Johnson. Motion carried.

Thomas Roemmich, II, Highway Superintendent provided his road report. No agreement has come from the Railroad for the additional funding at this time but Roemmich believes the agreement will be sent directly to the County Clerk.

An easement request was received from Crumbliss Farms, LLC to bore an electric line across County Road 302 from the SE ¼ of Sec 25-5-6 to the NE ¼ of Sec 36-5-6 for an irrigation well and pivot. Motion by Shaw and seconded by Pavelka to approve the easement request of Crumbliss Farms, LLC as requested. On roll call, yea: Bitterman, Becker, Pavelka, Shaw and Johnson. Motion carried.

Jeff Franklin, Clay County Sheriff, presented his monthly report.

Robin Gilbert, Clay County Treasurer, presented a Resolution to release a Pledge with Waypoint Bank. Motion by Becker and seconded by Pavelka to adopt Resolution #23-22 to release the Waypoint Pledge (CUISP #93811PBY3) as recommended by the County Treasurer. Mark Johnson, Courthouse Custodian, presented his monthly report.

Greg Shuck, Clay County Weed Superintendent, presented his monthly report. At this time, there is no plan for Household Hazardous Waste Recycling next year; the Electronic Recycling is expected to be next Fall.

Claims were submitted by the County Clerk to be reviewed. The General Fund does not have enough funds to cover the claims and a transfer of funds is needed from the Inheritance Tax Fund to the General Fund to cover the claims. Motion by Bitterman and seconded by Shaw to adopt Resolution #23-23 to transfer \$335,524.87 from the Inheritance Tax Fund to the General Fund to be paid back if/when funds are available.
