COUNTY BOARD OF SUPERVISORS MEETING MINUTES

The Clay County Board of Supervisors met at the Courthouse, Clay Center, Nebraska on April 23, 2024 at 9:00 A.M., as per public notice given in the Clay County News on April 17, 2024 a copy of the proof of publication being on file in the County Clerk's Office. Availability of the agenda was communicated in the advance notice of the meeting. All of the proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Chairman L. Wayne Johnson stated that the open meeting law poster is posted on the west wall in the back of the room and presided with roll call showing the following present: Eric Samuelson, Glen Becker, Jim Pavelka, Ivan Fintel, Richard Shaw and L. Wayne Johnson; Absent: Scott Bitterman.

Minutes of the meeting held April 16, 2024 were provided to the board members prior to the meeting. Motion by Fintel and seconded by Shaw to approve the minutes of the meeting held April 16, 2024. Upon roll call, the vote was as follows: Aye: Samuelson, Becker, Pavelka, Fintel, Shaw and Johnson; Nay: None. Motion carried.

Thomas Roemmich, II, Highway Superintendent presented his roads report.

An easement request was presented from Hamilton Telephone to bury fiber optic cable and conduit beginning 129 feet North of County Road 324, at the SE corner of 1-8-9 (Adams County), thence North for 1 mile to the NE corner of 1-8-9 (Adams County), along the East side of 1-8-9 on the West side of County Road A. Motion by Samuelson and seconded by Becker to approve the easement request as presented. Upon roll call, the vote was as follows: Aye: Becker, Pavelka, Fintel, Shaw, Samuelson and Johnson; Nay: None. Motion carried.

An easement request was presented from Timothy A. Nuss to bury an electrical line to power a center pivot from the NE ¼ of 12-8-6 crossing County Road T to the NW ¼ of 7-8-5. Jennifer Fleischer, County Attorney was present and advised the Board that at this time, there is no update on the process for vacating the roads in the NAD area.

Mark Johnson, Courthouse Building & Grounds, presented his monthly update.

Greg Shuck, Weed Superintendent, presented his monthly update and advised the Board that the tire recycling event will be scheduled for July 31, 2024.

A request to approve items for surplus was presented from the Clerk of the District Court. Motion by Shaw and seconded by Fintel to approve the following for surplus: metal file cabinet; computer desk and two IBM electric typewriters. Clerk Aksamit presented additional information regarding the inventory of the Courtroom technology from the recent upgrade done by the State of Nebraska. Motion by Becker and seconded by Shaw to approve and authorize the Chairman to sign the Statement of Acceptance of Possession and Future Responsibility of the inventory listing provided by CTI Complete of courtroom technology items that the Nebraska Administrative Office of Courts and Probation (AOCP) has purchased and installed for the County, which is accompanied by a five (5) year service agreement with CTI.
